Frequently Asked Questions

Can I modify the configuration?

Yes, from the administrator option you can modify the configuration and save it permanently.

What does the "continuous scan" option mean?

Each time the documents in the feeder run out, the scanner will wait for more documents without the action being completed.

What size is the most recommended? The regulations require the scan not to be less than 200px. That is why the minimum option is that format. In the event of an error, can I

interrupt the scan?

Yes, after starting the scanning process and while the task is in progress it has a "cancel" button to its right.

Where is the Authentic Copy process carried out?

It can be done 100% inside the HP equipment or outside, depending on the configuration.

Can I modify the metadata?

Yes, you can modify the metadata even if you have a predefined preset.

Answer: You can send the documents to a folder that is connected to other platforms or apps for document management, billing or any administrative process that you need. Objection: Our company does not have specialized personnel to carry out the installation of Copia auténtica inside an HP multifunctional.

Answer: Installation is done by your regular HP equipment supplier. Installation is not complicated; it is done directly from within the HP Command Center.
